

OHIO PUBLIC FACILITIES COMMISSION

Minutes of June 5, 2018 Meeting

The Ohio Public Facilities Commission held a meeting commencing at 3:30 p.m. on Tuesday, June 5, 2018, in the 35th Floor Conference Room, Office of Budget and Management, James A. Rhodes State Office Tower, 30 East Broad Street, Columbus, Ohio, pursuant to notice of meeting given by the Secretary pursuant to the Bylaws.

Mr. Scurlock reported for the Secretary that no new written designations, pursuant to Section 151.02 of the Revised Code and Section 2.1 of the Bylaws, were filed with the Secretary since the last meeting of the Commission.

Pursuant to the Bylaws, Mr. Grodhaus presided as Chair of the meeting and called the meeting to order. Upon roll call, the Chair declared a quorum to be present. The following member and designees of the members of the Commission, eligible to vote at the meeting, were present during the meeting:

Among others present were Kurt Kauffman, Larry Scurlock (Assistant Secretary) and Amber Teitt (Office of Budget and Management); Lisa Eisenberg (Treasurer of State); from Bond Counsel, Kip Wahlers (Ice Miller LLP); and from Issuer/Disclosure Counsel, Allison Binkley and Anthony Core (Squire Patton Boggs (US) LLP).

Mr. Scurlock filed the certificate* of compliance with the Commission's rule for notification of meetings to the public and news media.

Mr. Grodhaus then requested the minutes of the Commission's April 25, 2018 meeting be submitted for approval. Mr. Keen then moved, seconded by Ms. Rinehart, to approve those minutes. There being no discussion, upon roll call, the motion was approved as follows: Ayes – Grodhaus, Azoff, Rinehart, Nickey, Frass, and Keen; Nays – None. The Chair declared the motion passed and the minutes approved.

At the request of the Chair, Mr. Azoff then presented to the Commission the tabulation* of bids received until 10:30 a.m. for the State of Ohio \$300,000,000 Common Schools General Obligation Bonds, Series 2018A, for which the State has received the good faith deposit from the winning bidder in the amount and manner specified in the Official Notice of Sale.

There was then presented to the Commission completed Resolution No. 2018-5*, entitled “Series Resolution Providing for the Competitive Sale and Issuance of \$300,000,000 State of Ohio Common Schools General Obligation Bonds, Series 2018A.” It was moved by Mr. Keen, and Ms. Frass seconded the motion, that Resolution No. 2018-5 be adopted. Upon roll call, the motion was approved as follows: Ayes – Grodhaus, Azoff, Rinehart, Nickey, Frass, and Keen; Nays – None. The Chair declared the motion passed and Resolution No. 2018-5 adopted.

SERIES RESOLUTION
(COMMON SCHOOLS 2018A)

After a brief explanation of the following motion by Mr. Scurlock, Mr. Azoff moved, seconded by Ms. Nickey, that the Director of Budget and Management, as Secretary of the Commission and as that Director, is authorized and directed to make or cause to be made, with the assistance of his staff and advisers or others, all necessary and appropriate arrangements for the competitive sale and issuance by the Commission of not to exceed \$175,000,000 Infrastructure Improvement General Obligation Bonds, Series 2018A, with Roetzel & Andress, A Legal Professional Association serving as bond counsel and PFM Financial Advisors LLC serving as financial adviser, with formal authorization and award being subject to the Commission’s adoption of the Series Resolution providing for the issuance, sale and award of those Bonds. The motion was then approved on roll call as follows: Ayes – Grodhaus, Azoff, Rinehart, Nickey, Frass, and Keen; Nays – None. The Chair declared the motion passed.

There being no further business, the meeting was adjourned.
